## **Downtown Inspections Update**

JSA West Coast Regional Manager Amy Wenslow detailed the latest on downtown inspections in a recent conversation with DHF Downtown News. Since the end of February, the LA Department of Building & Safety (DBS) has conducted 1951 tenant usage inspections in the downtown Jewelry Mart area. As a result of those inspections, 1035 businesses received orders to comply.

Twenty-one downtown high rises have been inspected to date. "Inspections are ongoing and they intend to go to every building," stressed Wenslow. The DBS is on the lookout for violations that may include improper electrical wiring, improper plumbing fixtures, lack of mechanical ventilation and the use of unapproved equipment. These problems often stem from tenant or building improvements that are done without permits.

If DBS identifies a problem during an inspection, they will issue an order to comply, which stipulates the time allowed to fix that problem. If action isn't taken within the specified time, the DBS can fine, and eventually close the business. With building related problems, they can actually close the entire building.

The County Fire Department

makes inspections at the same time as the DBS. County Fire can cite businesses for not having an EPA ID number, for not having documentation to dispose of hazardous waste or for not having a CUPA permit for hazardous materials and waste.

The City Fire Department makes inspections separate from the DBS and County Fire Department. The Los Angeles City Fire Department has made over 1500 tenant inspections. Notices of violation include use of unapproved compressed gas, unsecured compressed gas tanks, improper extension cords, improper hose, improper torches and smoking in tenant spaces. City Fire can also cite businesses for having an extremely dirty office space, overflowing trashcans, and not having Material Safety Data Sheets (MSDS).

City Fire issues F315 permits which regulate the quantity of chemicals in the tenant space. They are issued after the inspection and must be posted in the tenant space. Wenslow also pointed out that propane is prohibited in any of the downtown buildings.

Wenslow sited an example of just how expensive a citation can be. If a citation for using an extension cord is issued and that extension cord is not upgraded within 30 days of the citation.

Her "Juxtaposed" stackable ring design (shown here) placed


"Juxtaposed" stacking ring set, made from DHF 18K Red, 18K White, 18K Yellow Gold.
